## Deutsches Schiffahrts museum

The "Travel-Workshop" is the first workshop of the interdisciplinary research project "Between the North Sea and the Norwegian Sea: Interdisciplinary Studies of the Hanse" funded by the Leibniz Association (Leibniz-Gemeinschaft) (2015-2018). The project focuses on the cultural and social links between the German cities of Bremen and Hamburg with the North Atlantic islands Faroe, Shetland and Iceland in the period c. 1400-1700.

The aim of this workshop is to bring together specialists from different disciplines and countries to shed light on several aspects of the process of traveling, and the stay of the Germans in their destination ports. The workshop is organized in two parts. The first session concentrates on the journeys: which ships were used for these journeys, what do we know about the crews, how did navigation work and which sea routes were used at that time? What were the climatic conditions and how did this affect sailing and navigation? The second session addresses questions regarding daily life on board. How was the provisioning on board and what happened when sailors fell ill? How was space on board organized? What do we know about religious life on board an on land?


